### MERCHANT WEBSITE REQUIREMENTS

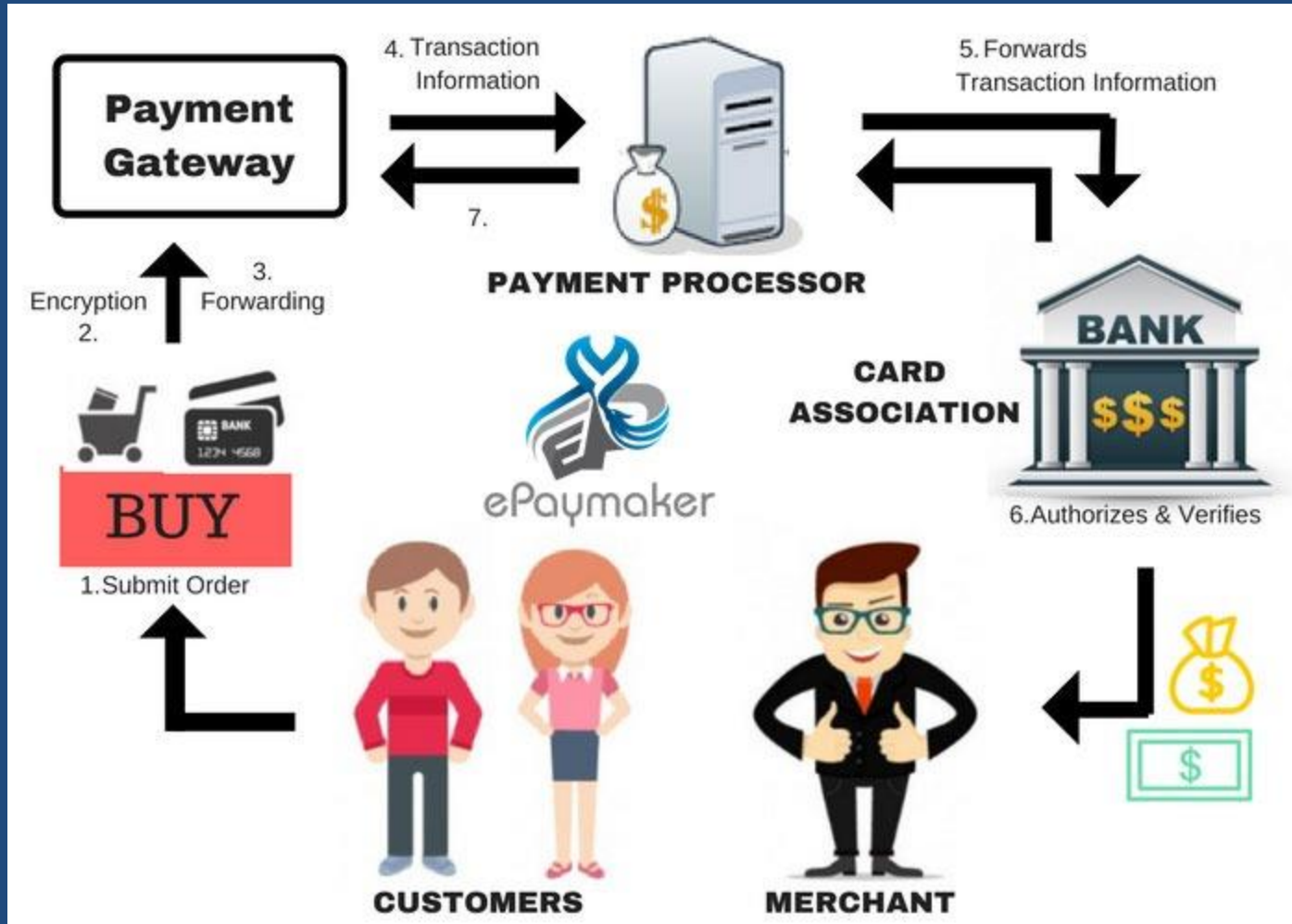
- Merchant must own the URL(s) - Proof of same as provided by whois registration.

- Clear posting of General Terms and Conditions
- Clear posting of delivery methods & timing
- Clear posting of the "billed as" descriptor on the payment page website checkout and order page should be Secure | SSL.

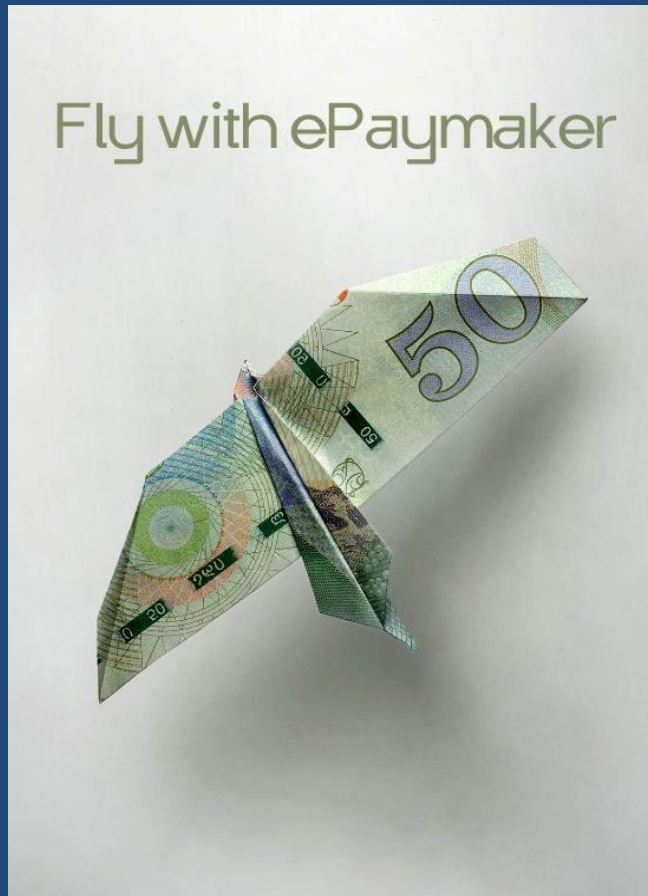
